## CLUB RULES

### Membership

- All Membership Subscriptions are to be paid within three calendar months of the Annual General Meeting (by 30<sup>th</sup> September) or the Membership will be cancelled. All new nominations for Membership or those failing to renew their Subscription by due date, will require a new nomination and seconded by current full Financial Members.
- All Nelson Competitors and Pit Crew Members are required to be Financial Members of the Nelson Club, the Competitor is responsible for their Crew and any Authorized Visitors they have. Competitors must also ensure that all infrequent Crew Members have purchased an armband to establish them as Authorized Visitors.
- No Competitors will be allowed to practice or race unless they are a Financial Member of a speedway Club and hold a Speedway New Zealand Competitors License.
- All Membership cards must include a photograph of the Member (head and shoulders similar to a passport photograph).
- Members need to carry their Membership Cards in and to access the Pit Area, Competitors may obtain an armband instead of carrying their Membership Card. Members must be able to produce their card on request for the Pit Area and for purchases from the Bar or Kitchen in the Clubrooms.

### Comprehensive Vehicle Inspection (green sheet)

- No CVI's (green sheeting) will be done at the track complex on race days unless special circumstances apply (i.e. Live out of town) and arrangements are made for it to be done earlier in the day.

### Grand Parade

- Only competitors may be on the outside of the Race Vehicle and only the person driving the car to be inside the Vehicle.
- No children in or on the Vehicle.
- No smoking or use of mobile phones or similar devices while on track for the Grand Parade.

### Practices

- Practices may be allowed before a Race Meeting if time permits, with prior approval from and at the Promoter's discretion.
- Practices may be allowed at the end of a Meeting if time permits and will be by prior approval from and only at the Promoter's discretion and also only if Speedway New Zealand Rules have been adhered too.

### General Racing

- Transmitters are compulsory in Nelson. All Transmitters must be working and correctly mounted. If a Competitor has no Transmitter or it is not working, then they will not be allowed to race. Failure to adhere to this will result in forfeiture of any prize or grid monies which would otherwise be paid by the Club. Exemption: Sidecars.
- Race Radio is compulsory for all National Classes, it is the Competitor's responsibility to ensure their radio is tuned to the Speedway New Zealand Chanel CH2409, frequency 455.056250 and ensure it is in good working condition.
- Any Competitor suspended by Speedway New Zealand for racing an illegal Vehicle will forfeit any prize monies and are ineligible for any Trophies earned whilst driving that non-compliant Vehicle and until the Vehicle is deemed compliant by Speedway New Zealand.
- No Smoking in the Dummy Grid area at all times.
- Competitors are required to obtain a Clearance to race at another Track on Nelson Speedway dates, even if their Class is on stand-down. Speedway New Zealand requires that clearances are obtained to race in an Allocated Title. Competitors that wish to race at another Track when their Class is scheduled to race at Nelson must apply in writing to the Committee at least three weeks prior to the Event. The Secretary requires time for the necessary paperwork to be done.
- All Competitors must supply a Bank Account Number for Prize and Grid Monies. Exception: Youth Ministocks.

### Pit Area

- Membership Cards will be used for access to the Pits for Nelson Adult Members. Authorized Visitor Armbands will only be issued to Youth Members who are Competitors or nominated Crew on the night, Visiting Competitors along with their Crew Members and purchased by/for infrequent Pit Crew Members.
- The Competitor is responsible for their Crew Members and must ensure they are Financial Members of the Club. This also applies to infrequent Crew, an armband must be purchased to establish them as Authorized Visitors.
- Members need to carry their Membership Cards to gain access and in the Pit Area, Competitors may obtain an armband. Members must be able to produce their Card on request for the Pit Area and for purchases from the Bar or Kitchen in the Clubrooms.
- Children under 12 years of age are not permitted in the Pit Area during racing. Any child that has no care giver arrangements in the Public Arena, an Indemnity Form (available from the armband table) must be completed by the Parent/Legal Guardian and the Competitor.
- The Pit Gate will remain closed for 15 minutes after racing finishes - to give the walking public free movement out of the Pit Pedestrian Gate and avoid congestion at our vehicle exit points.
- The consumption of alcohol, drugs or any banned substances, in the Pits during racing and at the conclusion of racing will result in Suspension from Racing or Officiating - Officials, Volunteers, Competitors, Visitors and Crews alike.

- Team Uniforms and/or Overalls and appropriate covered in Footwear is to be worn by Pit Crews and Visitors in the Pits at all times. Appropriate footwear does not include Jandals, Sandals, Ballet Flats or similar.
- Only one Tow Vehicle per Race Vehicle is allowed in the Pits. All other Vehicles are to be parked in the Public Carpark.
- If a Competitor needs to leave the premises during racing, before moving any vehicle from their designated Pit Area, they must first ask permission from a Committee Member at the Control Tower. Vehicles that line up at the gate cause congestion in the dummy grid area for Competitors still competing and service vehicles. Emergency exits must be kept clear at all times.
- Competitors that use a winch to load their Competiton Vehicle must have a competent person in the vehicle until the vehicle is tied down.

### Grounds

- The solid concrete seating area between turn two and turn three is designated as a Smoke Free Area.
- Overnight Camping in the car park at race meetings is permitted for Competitors only however they must be fully self-contained. The donation fee is \$10.00 per Campervan.
- The consumption of alcohol, drugs or any banned substances, in the Public Arena, the Pits or Carpark during racing and at the conclusion of racing will result in removal from the premises.

### Working Bees

- Every Member is required to attend at least one working bee during the Membership Year or assist the Club by other means at the approval of the Committee.
- Working Bees are usually scheduled for Saturday's or Sunday's, however other days and times are available on request.

### Abuse

- Nelson Speedway Association has a zero-tolerance policy on abuse of any kind. Any person that feels they have been abused needs to bring it to the committee's attention immediately. Any Competitor can and will be trailered if they, their Crew or their supporters abuse any other person on race night and the person will more than likely would be required to attend a meeting with Disciplinary Panel.
- It will be considered a breach of Club Rules for any Nelson Speedway Assn. Member to publish or permit to be published (Including Social Media) or connive at, any statement or conduct which improperly criticises any Member of Nelson Speedway Assn. or their Officials.

### Class & Team Funds

- All Class and Team bank accounts involved with Nelson Speedway Assn. are required to present Financial Accounts at the end of each year for auditing and copies to be made available for viewing by Members at the Annual General Meeting.
- A Member of the Executive Committee is required to be a Signatory on all Bank Accounts.

### Clubrooms

- All patrons must adhere to all current Club Liquor Licensing Legislation.
- Members are to produce their Membership Card on request to purchase Alcoholic Beverages.
- All non-members must be signed in as an Authorised Visitor in the Visitors Book by an Adult Member.
- Bring Your Own Alcohol is not permitted.
- No Alcoholic Beverages are to be taken out of the Licensed Area (past the Clubroom's Deck).

### General

- If an allocated key holder has misplaced their Complex Key and request a replacement a \$50.00 charge will be applied.
- Competitors, their Crews and their supporters are expected to display behaviour that would not be detrimental to Nelson Speedway while representing the Club as individuals or as part of a team.
- Every Member is required to attend at least one working bee during the Membership Year or assist the Club by other means at the approval of the Committee.
- If any Member has any issues, problems or constructive suggestions they need to contact the Club Captain, Competitors need to contact their Class Rep first, then the Club Captain.
- Donuts, Speeding, Roaring Around, Wheelies etc within the Complex is not permitted.
- Gambling at the Complex is not permitted.

- Live Streaming is not permitted.
